# Part 01: Qualification Suite Purpose Statement

### Qualification Suite Scope

**Transcend HEAT Operatives** is a progressive suite of vocationally related qualifications regulated by Ofqual. The qualifications in this suite sit in sector 1.3: Public services, are developed in collaboration with the **British Training Board [BTB]** and a<u>re</u> solely awarded by Transcend. Due to the n<u>ature</u> of the qualifications, they are delivered by BTB licenced education specialists. **The British Armed Forces recognise the BTB as the independent expert education provider** dedicated to supporting those in service, veterans, public servants, and their families throughout their careers and beyond.

The qualifications in this suite are relevant to those in occupational roles required to enter or operate in hostile environments. Learners will develop knowledge, skills and behaviours required to facilitate the safety and security of themselves and others in their operational context. These contexts may include but are not limited to military professionals, security contractors, first responders, paramedics, police, fire brigade, government officials, diplomats, foreign service officers, disaster relief workers, media operators such as journalists or photographers, oil and gas workers, environmental researchers, or educationalists. It is particularly relevant to veterans appointed to operate in a hostile context in a civilian occupation. The suite uniquely offers a progression route for trainees [L3], to established operators [L4] AND finally for team leaders [L5].

This suite is integral to the **Transcend BTB MVP¹ Portfolio.** This is a pioneering portfolio of qualifications developed specifically to align to the revolutionary **BTB Military Skills Translator Framework**. This **Portfolio** is therefore designed to enable our service men, women, and veterans to achieve qualifications recognised by civilian employers. The intent is to enable those that have served our country with pride to continue to thrive as they transition into the civilian community.

Qualification suite purpose	The purpose of the qualifications is to continue professional development. The sub-purpose is to knowledge and/or skills relating to legal, technical, process or best practice requirements.						
Qualification suite rationale	Across Great Britain, 2.03 million people reported that they had previously served in the UK armed forces (76% in the regular forces, 20% in the reserve forces and 4% in both). This represents 3.8% (almost 1 in 25) of the total population aged 16 or over. Overall, 7.0% of households in Great Britain included one or more veterans.
